President's Report — JoAnn Innerarity

JoAnn thanked Melissa for her dedication to HCRJ for the last 15 years and thanked Adam Forman for his leadership for the past two years. She also thanked all the staff for their hard work at HCRJ especially during Covid. HCRJ has fully resumed all activities since Covid. Some of the committees in the by-laws have been removed because it was felt that some were not needed. The president gave Michelle Leben a gift for her service on the board.

Approval of Minutes from 2022 Annual Meeting The minutes were approved.

Nominations — Adam Forman

The slate of nominations of officers and new board members were presented.

## Budget and Finance Report — Bruce Shelby

- Deficit Bruce stated there is a projected deficit of \$21,000 for this year.
- Expenses Security costs went up significantly this year. Funds, not from dues, is down \$25-30 thousand.
- Income from interest is up this year.
- For the past 5 years HCRJ has had a positive result at the end of the year.
- \$200 thousand comes in for specific items. (example: Religious school windows from a security grant awarded to HCRJ).
- 50% of our budget is dues which does not cover operating costs. Dues fell off during Covid.
- Presently cash on hand is 1.6 million. 1 million is unrestricted. At this time, cash position of HCRJ is very strong.
- Increase for next year to members will be \$200 per family for security and 3% annual increase in dues. Next year there will be an increase in security costs and donations are down.
- Projected a 12 thousand surplus for next year.
- Larry Buck acknowledged the great job Bruce has done managing the budget.
